#### **Service Benefit Plot Only**

- Plot allotted out of Defence Quota from GHQ AG's Branch (WR Dte).
  - ✓ NOC is mandatory for Offrs
  - ✓ NOC is not required for JCO / Havs (qualified only), War Wounded Person, Gallantry Award, Incentive Benefit, Compassionate Benefit, International Gold Medalist and Open Ballot Plots (in Defence Quota) wef 01 Jul 2022.
  - ✓ NOC is mandatory for NOKs and Legal Heirs of all Cats (GSB, BTM, GAB, GIB, GCB, WWP) in case of death of JCOs / Havs).

# **General / Special Power of Attorney**

• In case of Power of Attorney (GPA), original documents of General / Special Power of Attorney (GPA/SPA) will be submitted to **Legal Branch** for verification / legal opinion with paid fee challan Rs 15,000/-.

# NDC Fee / Charges - Fine Schedule

- Executive Transfer (NDC, Transfer & Transfer Letter) Fee Rs 50,000/- (within same day)
- <u>Urgent Transfer</u> (NDC & Transfer) Fee Rs 30,000/- (Within 24 hrs)
- Normal Transfer (Transfer) without any charges (over 48 hrs)
- Open Transfer NDC validity period of 90 days
- Walk in Transfer
   NDC already approved but transfer set deposited and transfer executed at same day without urgent charges

executed at same day without digent charges

- NDC rejected by Finance Branch (due to outstanding DC charges) can be approved without any charges within 3 months and after 3 months surcharge Rs. 10,000/- will be paid for approval.
- NDC extension fee after validity period of 90 days will be Rs 20,000/- for 15 days only.
- Conversion fee from normal to open tfr NDC will be Rs. 20,000/- (if applied through realtor).
- NDC Cancellation fee Rs. 20,000/- (if applied through realtor).
